Passing of the new code and zoning code has been postponed until January, codification company did not get finished document prepared in time for tonight's meeting.

Downtown sidewalk change order: Dalton Bailey motioned to accept change order in the amount of \$1,283.80 to finish west side sidewalk project, seconded by Skip James, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, yes, motion approved.

Payment to Schomburg and Schomburg: Dalton Bailey made the motion to make payment to Schomburg and Schomburg for construction of West side downtown sidewalk in the amount of \$52,469.83, seconded by Larry Oneal, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, yes, motion approved.

Water and Sewer Rates: Dalton Bailey motioned to pass Ordinance 12082025A, raising water rate minimum (1500 gallons) to \$49.00 (\$1 increase), and per thousand to \$11.50, (\$.50 increase), and continuing with the current \$11.00 maintenance fee, and Sewer rate minimum (1500 gallons) to \$41.00 (\$1 increase) and per thousand gallons to \$8.50 (\$.50) increase, seconded by Larry Oneal, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, no, John Dodd, no, and Dalton Bailey, yes. Motion approved.

Contract Wake up Ready, LLC: Tammy Boen motioned to pass Ordinance 12082025B, approving contract for rental of the west end of Village Hall to Wake up Ready, LLC, Sarah Summers, seconded by John Dodd, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, yes, motion approved.

East Downtown Sidewalk: Skip James motioned to enter into contract with Farnsworth to design the 100 block of South Main, East side sidewalk in the amount of \$44,300.00, seconded by John Dodd, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, no, motion approved.

TIF Amendment: Dalton Bailey motioned to approve Ordinance 12082025C, removing Ray Ryerson, and Larry Oneal's properties for the TIF district, seconded by Tammy Boen, roll call vote: Larry Oneal, recuse, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, yes, motion approved.

Water Main Bid: Larry Oneal motioned to accept bid from B&T Drainage in the amount of \$2,450,899.00, seconded by Dalton Bailey, roll call vote: Larry Oneal, yes, Skip James, yes, Tammy Boen, yes, John Dodd, yes, and Dalton Bailey, yes, motion approved.

- IEPA Loan forgiveness will be in the amount of \$896,545.00
- This bid approval includes the base project and alternate main replacements
- The total main replacement project before loan forgiveness is \$2988,649.00

**Meeting minutes for January 6<sup>th</sup>, 2026**

Commenced at 6:30pm.

Members present: Jim White (President), Gentry Hawkins (Secretary), Michael Collins, Elizabeth Stamps, Sawyer Longfellow, guests Dalton Bailey and Ray Ryerson.

Items discussed:

- a. Annexation of 5.2-acre property behind Casey's convenient store/gas station. This property currently has a large barn building owned by Dolton Bailey, whose current residence is adjacent to property on the south side.
- b. Changing the current zoning on the annexed property from "Agricultural" to "Commercial 2"

Discussion on accepting required Zoning Board of Appeals by Law.

- a. Discussion of the value of annexation of the property brought to light the added tax dollars to the village, bringing the property into the village's zoning area of responsibility and providing the homeowners with a joined piece of property for future considerations.
- b. Gentry Hawkins makes the motion to annex the property into the village, second by Sawyer Longfellow. Unanimous approval by all members present.

Discussion on changing the annexed property's zoning from "Agricultural" to "Commercial 2"

- a. Elizabeth Stamps made a motion to change the current zoning of the property from "Agricultural" to "Commercial 2" as this would allow the property to continue to have the ability to support a residential structure plus a form of business as needed, Michael Collins seconded the motion. Unanimous approval by all members present.

This concluded the business of this special meeting.

The meeting was adjourned at 7:00pm
